#### **QUALIFICATIONS:**

- 2. Must hold Maine Drivers License.
- 3. Demonstrated aptitude or competence for assigned responsibilities.
- 4. Ability to interact well with students, staff, and community.

**REPORTS TO:** Facilities and Transportation Director

**JOB GOAL:** To provide safe and efficient van transportation so that students may

enjoy the fullest possible advantage from the district's curriculum and

extracurricular program.

### PERFORMANCE RESPONSIBILITIES:

- 1. Obeys all traffic laws.
- 2. Observes all mandatory safety regulations for vehicles.
- 3. Maintains discipline when students are in van.
- 4. Reports all discipline issues to the Facilities and Transportation Director.
- 5. Keeps the assigned van clean.
- 6. Operates the assigned school van on the route(s) and schedule provided by the Transportation Department.
- 7. Checks van before each operation for mechanical defects.
- 8. Performs required pre-trip and post-trip inspections and maintains all trip documentation as required by the Transportation Department.
- 9. Notifies the Facilities and Transportation Director in case of mechanical failure or lateness.
- 10. Discharges students only at authorized stops.
- 11. Exercises responsible leadership at all times.
- 12. Transports only authorized students.
- 13. Reports all accidents and completes required reports.
- 14. Enforces all school policies pertaining to student transportation.
- 15. Performs such other duties and assumes such other responsibilities as the Facilities and Transportation Director may assign from time to time.

## **LEGAL AND ETHICAL DUTIES:**

- 1. Maintains confidentiality about all aspects of written and oral records.
- 2. Demonstrates a respect for the legal and human rights of students, instructors, and other staff.
- 3. Follows health and safety procedures established by the District.

- 4. Arrives and departs punctually, notifying appropriate personnel about absences and coverage.
- 5. Demonstrates dependability, integrity, and other ethical standards.

The responsibilities are representative of the knowledge, skills, and ability required.
